3	 Refining our recovery priorities Group discussion to clarify and rank our current recovery and resilience issues: Top concerns: Mental health Communication (not coordinated, incorrect, people unable to access) Advocacy on telecommunications As a group we advocate Infrastructure is not appropriately strengthened for resilience (build/replace so better and more resilient) In the middle: identify and educating about risk, advocate and educate. How to raise awareness of risks, emergency management arrangements, what people can do individually, empowering individuals Varied levels of understanding and awareness, you don't know what you don't know.

	 Not every locality has been impacted. How do you build resilience in this context
	 To be included in planning for future recovery scenarios: Centralised hubs for charities and recovery services generally (volunteers, include a buddy system to help people negotiate the grant application process) Assumption we have an equal capacity to recovery and prepare, especially in applying for recovery grants. The reality is that capacity is very uneven. Council is expected to do a lot, but not funded or mandated to do it, and definitely not on an ongoing basis. People don't have a home post-bushfire. State government guidelines and timeframes are not transparent. No action needed (out of scope for now?): Confusion and overwhelmed – multiple disasters, multiple processes Cost to fix things – emotional toll, monetary cost, government, long term approaches needed. Cascading disasters – drought doesn't get enough focus.
