Resolution?

People can self-refer to the free AIDER (Assist Infirm, Disabled and Elderly) RFS program https://www.rfs.nsw.gov.au/plan-and-prepare/aider.

People without an insurance resolution or are unhappy with their claim/payout can get free legal assistance/advice through legal aid.

Information given back to Jess. No further follow up needed

Can Council lobby?

Education to community members? Development of household plans so people know what their options are. Invite Police/LEOCON to talk to the group about processes

No easy resolution

Council develop a volunteer database (for spontaneous volunteers during a disaster, or before a disaster) Encourage people to register with existing volunteer services or local community hall/group. Could people register through the disaster dashboard? lifeline, Lions, Red Cross, Lions, BWNG all have volunteer databases

funding for infrastructure upgrades or ask RFS to change criteria or different designation

Could there be a registery of pre-existing new bores for RFS as safe water supply in a fire? More awareness of SWS. People install appropriate fittings on tanks for fire trucks to access. Council process to enable making their water trucks available. Could a grant process be set up for people to retrofit tank fittings

Community emergency plans - can they be registered with Council/LEMO/Emergency Services?
Janine to find out status of repairs on this road or if any strategic works planned
AUTHORITIES LISTENED TO WRONG PEOPLE - Unfortunately when agencies contacted communities to see if help was still needed, the people they spoke to had no idea who was actually still suffering and said everyone had recovered Luckily through other conversations with different people, the agencies found out that alot of people in that community had only just started recovery processes And needed help!
No-one knew what we were supposed to do, insurance companies were saying different things to different people. We were told take the help from the firies and army while they were there cos they won't be there long I would suggest a team of people go to each community when it's safe to return and explain, firies etc will be coming here in a couple of days They can help with Would U like help Between now and when firies come please try go through things and try salvaged what U wish (to make firies time used best and so nothing is accidentally disposed of)
More information on preparedness for all natural disasters, realistic expectations about how quickly they will get help. People painting house numbers on gutters and kerbs so homes are easier to locate
Global Care is able to provide emergency food boxes from Foodbank. Also able to do deliveries and bulk meals
Global Care are able to make Givit requests and special requests can be fast tracked
