INTRODUCTION TO LOCAL TRAFFIC COMMITTEE

The Local Traffic Committee is primarily a technical review committee that is required as a function of the delegation of authority to Council from Transport for NSW (TfNSW). TfNSW is the legislated organisation responsible for the control of traffic on all roads in New South Wales. The delegation of functions under the Roads Act 1993 allows Council to manage traffic on Regional and Local Roads, through the use of prescribed traffic control devices, once the advice of NSW Police and TfNSW has been obtained.

The Local Traffic Committee (LTC) is not a committee within the meaning of the Local Government Act, 1993. SUMMARY OF REPORT

Investigations have been undertaken to consider the installation of a No Stopping Zone upon Kent Street, Tuncurry, near the Tuncurry Ambulance Station.

SUMMARY OF RECOMMENDATION

It is recommended to install a No Stopping Zone upon the northern side of Kent Street, 1 metre from the western side of the Ambulance Station driveway and east to the Manning Street intersection.

FINANCIAL/RESOURCE IMPLICATIONS

Council will be responsible for the costs associated with the installation of signage and this work will be funded from the cost centres of Traffic Committee Items. The work has an estimated cost of \$800.

A: Tuncurry Ambulance Station- 58 Manning Street, Tuncurry -Proposed No Stopping zone upon Kent Street.

BACKGROUND

Council received a request from the Manning Duty Operations Manager – NSW Ambulance, to install a No Stopping Zone outside the Tuncurry Ambulance Station, located on the corner of Kent Street and Manning Street, Tuncurry. Vehicles are parking between the Ambulance driveway on Kent Street and Manning Street and affecting Ambulance accessing the station.

DISCUSSION

The Ambulance Station located at 58 Manning Street, Tuncurry and on the corner of Kent Street has Ambulance vehicle access from a driveway located on Kent Street.

The station driveway is a short distance from the intersection of Manning Street. Left turn only from Kent Street into Manning Street is allowed and has white pavement markings and sign posting to reinforce the left turn only.

Ambulance vehicles are exempt and allowed to turn right when responding to emergencies.

Vehicles that are currently parking in the proposed No Stopping Zone are forcing vehicles to drive in the middle of the road to negotiate the intersection.

Free parking is available nearby and across the CBD of Tuncurry.

The proposed No Stopping Zone, approximately 24 metres in length will direct vehicles not to park across the driveway and east to the intersection of Manning Street.

CONSULTATION

No businesses or residents will be affected by the change. Free parking is available in the vicinity. Councils Road Safety Officer met The Ambulance Manager onsite.

Several sites visits have confirmed vehicles are parking at the location and drivers leaving their vehicles.

COMMUNITY IMPACTS

The proposed No Stopping Zone will affect approximately 1 parking space suitable only for a small vehicle.

RECOMMENDATION

It is recommended to install a No Stopping Zone upon the northern side of Kent Street, 1 metre from the western side of the Ambulance Station driveway and east to the Manning Street intersection.
